## City, County Confirm New COVID-19 Related Deaths

LAREDO, Texas - The City of Laredo and Webb County have SEVEN new confirmed deaths in Webb County related to COVID-19. The City and County want to express their most sincere condolences to the families of those who have lost a loved one through this pandemic and want them to know that our counselors and our teams are available to support them.

The 603<sup>rd</sup> death of a Webb County resident was a male in his early-50's. He died Sunday, January 24, 2021.

The 604<sup>th</sup> death of a Webb County resident was a female in her early-80's. She died Sunday, January 24, 2021.

The 605<sup>th</sup> death of a Webb County resident was a female in her early-50's. She died Sunday, January 24, 2021.

The 606<sup>th</sup> death of a Webb County resident was a female in her early-50's. She died Monday, January 25, 2021.

The 607<sup>th</sup> death of a Webb County resident was a female in her late-60's. She died Monday, January 25, 2021.

The 608<sup>th</sup> death of a Webb County resident was a female in her late-90's. She died Sunday, January 24, 2021.

The 609<sup>th</sup> death of a Webb County resident was a female in her early-70's. She died Sunday, January 24, 2021.

Stay home if you are sick and call your doctor. Do not go to the doctor's office, call your doctor first. If it is an emergency, call 9-1-1.

As of **3:00 p.m. on Monday, January 25, 2021**, a total of : 257,662 people have been tested; 38,452 have resulted positive (1,991 are active); 35,852 persons have estimated recovered; 245 are currently hospitalized (77 of which are in the ICU), hospitalization rate is at 45.83% and 609 people have died.

In order to safeguard legally-protected information, the City of Laredo is not publicly releasing personal or identifiable information regarding any cases as it relates to COVID-19, results or monitoring.

Please continue to do your part in preventing the spread of all diseases. Follow the guidelines below:

- Follow CDC and WHO guidelines and practice physical distancing
- Wash your hands often with soap and water for at least 20 seconds. Hand sanitizer can be used when soap and water are not readily available
- Wear a mask or face covering
- Avoid touching your face
- Avoid close contact with people who are sick
- Stay home when you are sick
- Cover all coughs and sneezes
- Clean frequently-touched surfaces
