City, County Confirm No New COVID-19 Related Deaths

LAREDO, Texas - The City of Laredo and Webb County have **NO** new confirmed death in Webb County related to COVID-19. The City and County want to express their most sincere condolences to the families of those who have lost a loved one through this pandemic and want them to know that our counselors and our teams are available to support them.

Stay home if you are sick and call your doctor. Do not go to the doctor's office, call your doctor first. If it is an emergency, call 9-1-1.

As of **12:00 p.m. on Friday, May 7, 2021**, a total of: 338,968 people have been tested; 43,962 have resulted positive (5/06/21: 43,942); 127 are estimated active (5/06/21: 152); 43,000 persons are estimated recovered (5/06/21: 42,955); 14 are currently hospitalized (1 of which are in the ICU); hospitalization rate is at 3.32% (5/04/21: 3.23%) and 835 people have died.

Vaccine Statistics:

First Doses Administered: 144,970 (73.62%)

Fully Vaccinated: 103,977 (52.80%)

65+ population who have received a vaccine: 23,405 (83.88%)

In order to safeguard legally-protected information, the City of Laredo is not publicly releasing personal or identifiable information regarding any cases as it relates to COVID-19, results or monitoring.
