City, County Confirm New COVID-19 Related Deaths

LAREDO, Texas—The City of Laredo and Webb County have **EIGHT** new confirmed deaths in Webb County related to COVID-19. The City and County want to express their most sincere condolences to the families of those who have lost a loved one through this pandemic and want them to know that our counselors and our teams are available to support them.

The 404th death of a Webb County resident was a male in his early-80s. He died on Monday, November 30, 2020.

The 405th death of a Webb County resident was a female in her late-80s. She died on Monday, November 30, 2020.

The 406th death of a Webb County resident was a female in her early-80s. She died on Tuesday, December 01, 2020.

The 407th death of a Webb County resident was a male in his mid-70s. He died on Tuesday, December 01, 2020.

The 408th death of a Webb County resident was a male in his mid-50s. He died on Monday, November 30, 2020.

The 409th death of a Webb County resident was a male in his early-60s. He died on Sunday, October 04, 2020.

The 410th death of a Webb County resident was a male in his early-70s. He died on Wednesday, November 11, 2020.

The 411th death of a Webb County resident was a female in her late-70s. She died on Sunday, November 08, 2020.

Stay home if you are sick and call your doctor. Do not go to the doctor's office, call your doctor first. If it is an emergency, call 9-1-1.

As of 12:00 p.m. on Tuesday, December 01, 2020, a total of 126,510 people have been tested, 20,280 have resulted positive (1,025 are active), 18,844 persons have estimated recovered, 147 are currently hospitalized (47 of which are in the ICU), hospitalization rate 28.1% and 411 have died.

In order to safeguard legally-protected information, the City of Laredo is not publically releasing personal or identifiable information regarding any cases as it relates to COVID-19 testing, results or monitoring.

Please continue to do your part in preventing the spread of all diseases. Follow the guidelines below:

- Follow CDC and WHO guidelines and practice physical distancing
- Wash your hands often with soap and water for at least 20 seconds. Hand sanitizer can be used when soap and water are not readily available
- Wear a mask or face covering
- Avoid touching your face
- Avoid close contact with people who are sick
- Stay home when you're sick
- Cover all coughs and sneezes
- Clean frequently-touched surfaces
