City, County Confirm New COVID-19 Related Deaths

LAREDO, Texas—The City of Laredo and Webb County have **SIX** new confirmed death in Webb County related to COVID-19. The City and County want to express their most sincere condolences to the families of those who have lost a loved one through this pandemic and want them to know that our counselors and our teams are available to support them.

The 421st death of a Webb County resident was a female in her mid-70s. She died on Saturday, December 05, 2020.

The 422nd death of a Webb County resident was a female in her early-80s. She died on Sunday, December 06, 2020.

The 423rd death of a Webb County resident was a male in his early-50s. He died on Monday, December 07, 2020.

The 424th death of a Webb County resident was a male in his late-70s. He died on Monday, December 07, 2020.

The 425th death of a Webb County resident was a female in her midy-70s. She died on Monday, December 07, 2020.

The 426th death of a Webb County resident was a male in his mid-80s. He died on Monday, December 07, 2020.

Stay home if you are sick and call your doctor. Do not go to the doctor's office, call your doctor first. If it is an emergency, call 9-1-1.

As of **12:00 p.m. on Tuesday, December 08, 2020**, a total of 141,438 people have been tested, 21,848 have resulted positive (1,465 are active), 19,957 persons have estimated recovered, 153 are currently hospitalized (48 of which are in the ICU), hospitalization rate 29.9% and 426 have died.

In order to safeguard legally-protected information, the City of Laredo is not publically releasing personal or identifiable information regarding any cases as it relates to COVID-19 testing, results or monitoring.

Please continue to do your part in preventing the spread of all diseases. Follow the guidelines below:

- Follow CDC and WHO guidelines and practice physical distancing
- Wash your hands often with soap and water for at least 20 seconds. Hand sanitizer can be used when soap and water are not readily available
- Wear a mask or face covering
- Avoid touching your face
- Avoid close contact with people who are sick
- Stay home when you're sick
- Cover all coughs and sneezes
- Clean frequently-touched surfaces
