# **City, County Confirm New COVID-19 Related Deaths**

**LAREDO, Texas**—The City of Laredo and Webb County have **FIVE** new confirmed death in Webb County related to COVID-19. The City and County want to express their most sincere condolences to the families of those who have lost a loved one through this pandemic and want them to know that our counselors and our teams are available to support them.

The 427<sup>th</sup> death of a Webb County resident was a female in her early-80s. She died on Tuesday, December 08, 2020.

The 428<sup>th</sup> death of a Webb County resident was a female in her late-60s. She died on Tuesday, December 08, 2020.

The 429<sup>th</sup> death of a Webb County resident was a male in his early-70s. He died on Tuesday, December 08, 2020.

The 430<sup>th</sup> death of a Webb County resident was a female in her mid-60s. She died on Thursday, November 19, 2020.

The 431<sup>st</sup> death of a Webb County resident was a male in his mid-50s. He died on Saturday, November 07, 2020.

Stay home if you are sick and call your doctor. Do not go to the doctor's office, call your doctor first. If it is an emergency, call 9-1-1.

As of **12:00 p.m. on Wednesday, December 09, 2020**, a total of 142,957 people have been tested, 22,417 have resulted positive (1,656 are active), 20,330 persons have estimated recovered, 136 are currently hospitalized (49 of which are in the ICU), hospitalization rate 33.3% and 431 have died.

In order to safeguard legally-protected information, the City of Laredo is not publically releasing personal or identifiable information regarding any cases as it relates to COVID-19 testing, results or monitoring.

Please continue to do your part in preventing the spread of all diseases. Follow the guidelines below:

- Follow CDC and WHO guidelines and practice physical distancing
- Wash your hands often with soap and water for at least 20 seconds. Hand sanitizer can be used when soap and water are not readily available
- Wear a mask or face covering
- Avoid touching your face
- Avoid close contact with people who are sick
- Stay home when you're sick
- Cover all coughs and sneezes
- Clean frequently-touched surfaces
