<b>Building &amp; Property Maintenance</b> Includes plumbers, electricians, roofers, exterminators, air condition repair, gardeners.	<b>Adult Day Care</b> Must comply with the Texas Health and Human Services Commission Guidance on COVID 19 Response in DAHS Facilities and limit meal times and activities to smaller groups (10 or less) to maintain distance among staff and clients.	<b>Amusement Redemption Centers</b>
<b>Financial Institutions</b> Includes banks, financial institutions, credit unions, consumer lenders, appraisers, title, pawn shops and other related companies.	<b>Child Day Care</b> Maximum of ten (10) people including staff per enclosed space and must remain in the same group at same time.	<b>Bars</b> Includes Taverns, lounges, nightclubs.
<b>Communications &amp; Information Technology</b> Includes internet, cable, cellular, telephone, and other communication services.	<b>Cleaning Services</b> Includes janitorial, home cleaning, pool cleaners, car washes, Laundromats, dry cleaning/ironing. Must comply with social distancing guidelines allowing sufficient space for all people to be six (6) feet apart at all times.	<b>Beauty &amp; Personal Care</b> Includes all Hair, Nail & Tanning Salons, Barber Shops, Estheticians, & Spas.
<b>Construction</b> Includes Public Works, Residential & Commercial.	<b>Convenience Stores</b> Maximum of ten (10) people including staff per enclosed space and practicing of social distancing guidelines with sufficient space for all people to be six (6) feet apart at all times	<b>Bingo Halls</b>
<b>Delivery Services</b> Includes UPS, Fed Ex, USPS, etc.		<b>Book Stores</b>
<b>Law Enforcement, Public Safety, and First Responders</b> Law Enforcement, Fire and Rescue Services, Emergency Medical Service Providers, Private Security, Public Safety/911 Call Center Employees		<b>Cosmetic, Beauty Supplies, &amp; Perfume Stores</b>
<b>Grocery Stores</b> Includes HEB, Target, Wal-Mart, Meat markets, Dollar Stores, Walgreens, CVS, etc.	<b>Funerals</b> Maximum of ten (10) people including employees per enclosed space.	<b>Craft Stores</b> Including Michaels & Hobby Lobby
<b>Hardware &amp; Home Stores</b> Includes Lowes, Dr. Ike's, Home Depot, Ace, True Value, and similar stores.	<b>Government</b> Utilities, telecommunications, trash collection & disposal, law enforcement, EMS/ambulance, corrections, dispatch, animal care services, governmental employees deemed non-essential and/or unable to perform work from home and sent home by the government entity.	<b>Entertainment Venues</b> Includes theatres, bowling alleys, concerts, etc.
<b>Automobile Dealerships and Auto Repair</b>	<b>Gun &amp; Ammunition Stores</b> Maximum of ten (10) people including staff per enclosed space. <i>Opinion No. KP-0296</i>	<b>Event Meeting Centers</b> Includes Hotel & Residential Meeting Centers, Ballrooms, Reception Halls, Party Rental Places, & Plazas.
<b>Liquor Stores</b>	<b>Nursing/Retirement Homes &amp; Long Terms Care Facilities</b> May not allow people to visit unless there to provide essential services.	<b>Flea Markets</b>

<p align="center"><b>Media</b></p> <p>Includes newspaper, television, &amp; radio.</p>	<p align="center"><b>Professional Services</b></p> <p>Professional services such as notaries, legal, accounting, residential and commercial real estate services including settlement services, and insurance <i>only when</i> distance working is not possible and <i>only if</i> necessary to assist clients with legally mandated activities; or to conduct minimum necessary activities (making it possible for employees to continue to work remotely from work; ensuring security, processing payroll, or related functions).</p>	<p align="center"><b>Furniture &amp; Mattress Stores</b></p>
<p align="center"><b>Fabric Stores</b></p>		<p align="center"><b>Gyms</b></p> <p>Includes fitness classes, yoga and personal training facilities, similar facilities and classes where people go to engage in any form of physical exercise.</p>
<p align="center"><b>Healthcare</b></p> <p>Hospitals, Clinics, Dentists, Pharmacies, Pharmaceutical and Biotechnology Companies, Healthcare Suppliers (including fabric stores), Optical Suppliers, Mental Health Providers, Substance Abuse Service Providers, Blood Banks, Medical Laboratory Services, Veterinary Care Facilities.</p>	<p align="center"><b>Religious Services</b></p> <p>Can be provided by video or teleconference only. Only ten (10) employees/volunteers preparing for video or teleconference services are allowed in the same room and must practice social distancing guidelines with sufficient space for all people to be six (6) feet apart at all times.</p>	<p align="center"><b>Jewelry, Luggage, &amp; Leather Goods Stores</b></p>
<p align="center"><b>Office Supply Stores</b></p> <p>Includes Office Depot, Office Max, Patria Office Supply, etc.</p>	<p align="center"><b>Restaurants</b></p> <p>Includes coffee shops, food trucks, raspa trucks, bakeries, foot courts, cafeterias, ice cream parlors, and any other business that sells food or drinks provided that service is limited to delivery or curbside.</p> <p>All restaurants must implement necessary safety protocols such as ensuring employees practice social distancing and do not work within six (6) feet of one another, provide hand washing stations, hand sanitizer, and make tissue available to employees, frequently clean and disinfect high touch surface areas, and utilize personal protective equipment when interacting with attendees/customers outside; and inside.</p>	<p align="center"><b>Malls</b></p> <p>Includes Mall Del Norte &amp; the Outlets.</p>
<p align="center"><b>Pet Services</b></p> <p>Includes veterinarian services, pet grooming, and pet stores.</p>		<p align="center"><b>Musical Instrument Stores</b></p>

<p align="center"><b>Public Agency Workers</b></p> <p>Includes those that respond to abuse and neglect of children, elders, and dependent adults.</p>	<p align="center"><b>Schools</b></p> <p>Includes all type of instruction including vocational, driving, public/private schools and institutions of higher learning. Only allows employees that practice social distancing guidelines with sufficient space for all people to be six (6) feet apart at all times and for purposes of conducting minimum necessary activities that include: facilitating distance learning or making it possible for employees to continue to work remotely from work; processing payroll and employee benefits, or for related functions; and picking up by, or providing food to, students or members of the public on a pick-up or take-away basis.</p>	<p align="center"><b>Private Clubs</b></p>
<p align="center"><b>Transportation &amp; Moving Services</b></p> <p>Includes airport, buses, taxis, ride share companies, U-Haul, and self-storage companies.</p>		<p align="center"><b>Private Gatherings</b></p> <p>Any number of people at any private residential dwelling, commercial building, office, or public place not deemed an essential activity.</p>
<p align="center"><b>Warehouse, Distribution &amp; Fulfillment Center</b></p> <p>Includes Customs Brokers</p>	<p align="center"><b>Travel</b></p> <p>To return to a place of residence from outside the jurisdiction or for any travel inside and outside the jurisdiction related to permissible Essential Activities, Healthcare, Governmental Functions, Critical Infrastructure, and Essential Businesses.</p>
