Planning Director Orlando Navarro stated that the commission had met and approved the plan that is before council. MPT. Rodriguez asked if it was a time sensitive item. Mr. Navarro stated that we have enough time and City Secretary Jose Valdez Jr. stated that it was time sensitive. Mr.

Valdez explained that the plan becomes effective after 181 day after it is approved. The will affect the upcoming election when candidates submit applications, will they be running under the old boundary lines or the new ones. Chairman of the Commission Donato Dennis Ramos stated that they used the 2020 U.S. census population data which assumed around 255 thousand residents so the goal of the commission was to get around 31 thousand resident per district. We met our statistical mandate of less than 10% deviation between districts. Cm. Martinez thanked the commission for the time and effort they spent working on the proposed plan.

Cm. Torres requested individual map that show street and that he had already requested that. Cm. Perez asked for the different plans that were presented. MPT Rodriguez stated that that request was close to gerrymandering and we should not do that and have as little say so as possible. Cm. Torres and Perez disagreed and stated that they have all the say so. Mr. Navarro stated that keeping the precincts whole was their number one priority. Cm. Gonzalez did not agree with what he was seeing and felt that the presented map looked fishy.

CM. Perez stated that she thought that the positions were not necessary and they were not in the budget and that is why she's against the item. Cm. Gutierrez disagreed with his colleague and is in total favor of the item. He mentioned that the assistances are torn in half between two council members and if we both have things going on during the day it becomes hard for them to work on both projects. Cm. Torres asked management if they are looking for money or scrambling for funds since they put the item on the agenda. Mr. Robert Eads mentioned that during his evaluation council mentioned the greater need of council assistants he talked about how he could do it. Cm. Torres asked Mr. Eads if he needed more staff to manage the city council. His answer was that he would make it manage. MPT. Rodriguez asked he why then are their projects not getting done. Can I get a breakdown of the \$313,000 because I feel the it's not that amount. Deputy City Manager Rosario Cabello she mentioned that it include expenses for offices in addition to other considerations. MPT. Rodriguez disagreed with her and stated that there are plenty offices in the city building. Cm. Cigarroa said that in a perfect world it would be great that each one of us has an assistant but that is not the priority at the moment. By having more assistants it will not help we have greater needs though out the city. Cm. Perez said that having a council assistant will not push projects forward because we do not have the personnel. Mr. Eads responded with the fact that staff has been doing more with less people. Cm. Torres stated that before the item made it to the agenda, Mr. Eads should have explored the creative ways of getting things done before opening up a can of worms here.

Cm. Gutierrez and MPT. Rodriguez had an issue with have people pay a fee for providing their own traps. Animal Carew Services Director Karina Elizondo explained why they wanted a fee and wanted people to provide proper traps that will not hurt animals. Cm. Torres explained why he felt that the fee was appropriate; he also told a story of an incident involving a cat the tragic ending. Cm. Torres suggested that it be a requirement to register your trap and failure to register ends up in a citation and the Municipal Court Judge decides the fine. Cm. Dr. Martinez felt that ratepayer or taxpayers should have to pay this. If people aren't taking care of their pets, pets are getting out then, and we have to cover that cost, the cost is marginal and it gives us some money to try to fight the pet population. If someone is taking the time to buy their \$100 trap, I don't think it is a stretch to think that these people would pay \$25 registration fee because they would be taught how to properly trap animals. Cm. Perez mentioned that the bigger problem was the spade and neutering of stay animals. MPT. Rodriguez still had concerns with having people having to pay, it's an extra burden on them and that's not right. Cm. Torres mentioned that it also happens in the inner city not just on the outskirts of the city.
